Your other account number, which begins with "9" or "00000", covers all other personal property at your location. Please refer to these account numbers in any communication with the District.

Your monthly sales-based taxes on the Dealers Inventory for the year 2010 are calculated based on the 2009 tax rates for your location, which vary according to School District and City. A tax rate with the tax factor is listed above for your reference.
